DEGREE NOMENCLATURE AND LEVEL


The degree shall have the title of "**Bachelor of Laws (LLB)**" and level 6 of the National Qualifications Framework of the HEC).

ELIGIBILITY CRITERIA

Higher Secondary School Certificate/A-levels (involving **12 years of schooling**) or an IBCC equivalent qualification with minimum **45% marks** is the eligibility requirement for admission in the LLB Programme. **50% score in Law Admission Test (LAT)** conducted by ETC-HEC is mandatory.

LL.B PROGRAMME STRUCTURE

The LLB programme follows HEC Undergraduate Education Policy 2023 V 1.1 provisions and comprises a minimum of 08 regular semesters (Four Years). Present LL.B scheme of study consisting 147 credit hours that are reasonably set to achieve the desired Programme Learning Outcomes.







Decisions:

1. There shall be no restriction on admission to the LL.B program based on upper age limit or academic gap, provided the candidate fulfills all admission requirements, such as, 12 years of education and a passing score on the HEC LAT, since there no bar in the Pakistan Bar Council Legal Education Rules, 2015, as well.
2. As per HEC's Undergraduate Education Policy, 2023 the students must complete a 3-credit internship, by spending 06-08 weeks in court under the supervision of senior advocate of Bar Council. Upon completion, the internee must submit a certification, internship report, and case participation proof,

which will be Evaluated through the viva by the department/college committee.

3. A minimum of 75% attendance is mandatory in each semester for students to be eligible to appear in the final examinations.
4. To promote to the next academic year/part, a student must maintain a minimum CGPA of 2.00 out of 4.00 and pass at least three subjects in a semester. Failure to meet these requirements the student will be dropped to same year/part. Continued failure for three consecutive years, or failure to meet the minimum CGPA requirement, will lead to cancellation of admission.
5. The Capstone Project is officially scheduled for the 8th semester. However, the department or college will ensure to initiate its process at the beginning of the 7th semester. This includes selecting a topic and submitting the project proposal through departmental or college Research Committee, both of which must be completed before the end of the 7th semester.
6. The course Fehm-e-Quran is designated for Muslim students. Non-Muslim students may instead opt for a course world Religions.
